BUSINESS ITEMS

1. EQUIPMENT PURCHASES FOR CALIMESA FIRE DEPARTMENT AND WAIVER OF FORMAL BIDDING AND THE REQUIREMENT FOR THREE BIDS FOR SOME OF THE EQUIPMENT PURCHASES.

RECOMMENDATION: That the City Council approve Resolution No. 2017-19, a Resolution of the City of Calimesa amending the 2017-2018 adopted budget to include equipment purchases necessary for the establishment of the new Calimesa Fire Department and waiving formal bidding and minimum bid requirements in connection with certain equipment purchases as provided by the City's Municipal Code.

City Manager Johnson presented the agenda report. Fire Consultant Jock Johnson responded to questions of the City Council. City Manager Johnson provided an amended Resolution No. 2017-19, amending the dollar amount in Section 1 to a reduced amount and amending Exhibit B to include a lower purchase amount for the self-contained breather apparatus compressor and fill

station. The Fire Facilities Fund was reduced from \$290,692 to \$289, 643 and reflected in the Resolution. Council Member Hyatt questioned the purchases of Fire trucks and command vehicles. City Manager Johnson stated that those purchases would come back to the Council at a later date.

After Council discussion, the following action was taken:

MOTION BY MAYOR PRO TEM DAVIS, SECONDED BY COUNCIL MEMBER MOLINA, CARRIED 5-0 TO APPROVE RESOLUTION NO. 2017-19 WITH AMENDMENTS, A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CALIMESA AMENDING THE 2017-2018 ADOPTED BUDGET TO INCLUDE EQUIPMENT PURCHASES NECESSARY FOR THE ESTABLISHMENT OF THE NEW CALIMESA FIRE DEPARTMENT AND WAIVING FORMAL BIDDING AND MINIMUM BID REQUIREMENTS IN CONNECTION WITH CERTAIN EQUIPMENT PURCHASES AS PROVIDED BY THE CITY'S MUNICIPAL CODE.
