CHAMBER OF COMMERCE REPORTS

Chamber President Duvall reported the following: attendance at the SCE Big Creek Tour, successful Texas Hold'em Fundraising event, raised \$4,000 in scholarships, took metro link route to Burbank Airport, Chamber Breakfast was held, PASSCOM President was the speaker, attended Calimesa Lyons Club Golf Tournament, distributed welcome bags to new residents and new business owners. She announced the annual State of the City event that would be held on Thursday, September 27, 2018. She announced a Christmas parade meeting on September 18, 2018, Veterans Expo Job Faire at Beaumont City Hall on September 20, 2018 and T-Now kick-off for Route 125 on September 21, 2018. She further announced an ice cream social with Mesa Grande Academy on October 18, 2018 and the Sr. Center Boutique ribbon cutting on October 24, 2018.

POLICE CHIEF COMMENTS & REPORTS

Police Chief Pemberton reported Traffic Collisions up from last year as well as DUI arrests. He further reported that the homeless issue is at the forefront, stating the the County DPSS placed more individuals. He stated that there are approximately 15-20 homeless individuals in Calimesa.

FIRE CHIEF COMMENTS & REPORTS

Fire Chief Johnson reported 1,326 calls for service since January 1, 2018. He further

reported that the fire prevention Marshall issued 14 new construction permits, 14 sprinkler permits and completed 22 annual business inspections. He expressed his thanks to Justine Rider, Manager of Ace Hardware in Yucaipa for the large discount on a new barbeque grill for the station. He spoke regarding a robo caller scam going around to Calimesa residents stating that they are taking donations for the Fire Department. Staff reported the scam to the Sheriff's department who confirmed it was a scam. Chief Johnson introduced Helen Welch from the Beaumont Wal Mart and expressed his thanks for 40 cases of water and 30 cases of Gatorade for the Fire Station. Mayor Hewitt presented her with a Certificate of Appreciation.
