### Mobile Home Rent Stabilization Board

Purpose: The Mobile Home Rent Stabilization Board is responsible for examining any rental agreement submitted to the board by any party to the rental agreement for the purpose of determining whether the space is subject to rent control under the Ordinance when reviewing a petition for a rent adjustment. Receive, investigate, conduct hearings on and approve, conditionally approve or disapprove petitions for, or protests against, adjustments of rents in mobile home parks. Conduct such studies, surveys, investigations and public hearings and obtain such information as may be necessary to carry out its duties. Subject to the approval of the city council, to adopt, promulgate, amend and rescind such administrative rules and regulations as the board finds reasonable and necessary for the conduct of its affairs and to implement and administer the provisions of the ordinance.

## Planning Commission

Purpose: The Planning Commission is a five-member body. Members are appointed by each City Council Member and serve terms consistent with those of the Council Member who appointed them. The Commission’s functions, established by Calimesa Municipal Code Chapter 2.45, include:

- Prepare, periodically review, and revise as necessary the general plan.
- Implement the general plan through actions including, but not limited to, the administration of specific plans, zoning and subdivision ordinances.
- Annually review the capital improvement plan of the city and the local public works projects of other local agencies for their consistency with the general plan, pursuant to Title 7, Division 1, Chapter 3, Article 7 (commencing with Section 65400) of the Government Code.
- Endeavor to promote public interest in, comment on, and understanding of the general plan, and regulations relating to it.
- Consult and advise with public officials and agencies; public utility companies; civic, educational, professional, and other organizations; and citizens generally concerning implementation of the general plan.
- Promote the coordination of local plans and programs with the plans and programs of other public agencies.
- Perform such other functions as are required by the planning and zoning law and as may be provided by the city council, including conducting studies and preparing plans other than those required or authorized by the planning and zoning law.
