Site Plan Requirements

(Site Plan Application Attached)

The following information is required on the primary exhibit or maps:

- Completed application with name, address and telephone number of applicant.
- Name, address and telephone number of landowner, if different.
- Name, address and telephone number of map or exhibit preparer.
- Assessor's Parcel Number(s).
- Plans must be drawn to scale.
- North arrow (orient to top of map or exhibit).
- Map Number if applicable.
- Proposed lot or space boundary lines, net acreage/square footage, and dimensions. Overall dimensions of the property and location of adjoining lot lines.
- Legal description of property.
- Vicinity map, show site's relationship to major highways and cities, and two paved accesses. Heavy dark lines will indicate paved roads (City Streets).
- Thomas Brothers map page and coordinates.
- Date map(s) or exhibit(s) were prepared.
- A statement indicating that the tentative map includes the entire contiguous ownership of the land divider or only a portion thereof.
- Existing and proposed zoning and land uses of the subject property and all adjoining property.
- Name and mailing address of property owners within a 300 ft. radius of the project site.
- One 30" X 42" standard site plan and additional exhibits.

Applicants will provide the Planning Department with fifteen (15) sets of the following plans (if applicable):

- Site plan – Please include on the fully dimensioned site plans: type and height of any fencing, numbered parking spaces, including loading zones (if commercial/industrial), show designated areas of landscaping, materials to be used for parking area, and Riverside County Fire Department approved screening of the fire back flow device;
- Landscape site plan shall include the following: fully dimensioned areas of landscaping, box sizes of all trees to be planted, the Latin and common names of all plants, trees, etc. to be planted;
- Elevations – North, West; South, East;
- Building sections should show any roof mounted equipment, as well as screening of any roof mounted equipment;
- Grading Plans showing flow of water runoff;
- Photometric Plan
